Academic coursework or teaching	From an accredited college or university: Must be related to the content areas of the examination. Classes can be on-line or in classroom setting. If teaching, it is not your full time job. (one semester credit hour = 15 contact hours; one quarter credit hour = 10 contact hours)	Transcript only or letter from academic institution	Maximum - 25 contact hours for this section
Authoring, Editing, Publishing	Authoring/editing an article, chapter or textbook published in professional journals, periodicals, textbook or via other media related to legal nurse consulting. Must have the author's name, publication name, and date of publication. (authoring/editing a book or chapter = 15 contact hours; authoring an article = 7.5 contact hours)	Copy of article, or reference to chapter, book	
Professional Presentation	At an educational program or meeting of a national, regional, state or local professional association or society in a topic related to the content area of the examination. (one hour presentation = one contact hour)	Copy of program with your name and time presenting	
SME Test item writing	Actual hours worked as SME item writer for LNCC examination.	Letter from ALNCCB	Maximum - 25 contact hours for this section
AALNC/ALNCCB Board of Directors or Committees	Participation in scheduled meetings, workshops or working sessions on Board of Directors or Committee participation at either chapter, state or national level of AALNC or ALNCCB. (1 year of Board or Committee participation at chapter, state or national level = 5 contact hours)	Letter from Chapter President or Board Chair for AALNC/ALNCCB
